The undersigned ("*Trading Advisor*"), named in Limited Power of Attorney executed between Trading Advisor and _____ (the "*Customer*"), has read the Customer Agreement between Alpari (US), LLC ("*Alpari*") and the Customer and agrees to abide by all the applicable terms and conditions set forth therein and further agrees to comply with all applicable law, rules and regulations.

TRADING ADVISOR DECLARATION

Trading Advisor acknowledges that it has been designated as the Customer's trading agent and attorney-in-fact pursuant to the Limited Power of Attorney referenced above. Trading Advisor hereby represents and warrants to Alpari that Trading Advisor has reviewed the registration requirements of the Commodity Futures Trading Commission ("*CFTC*") and National Futures Association ("*NFA*") relating to commodity trading advisors ("*CTA*") , as amended, and is either appropriately registered with the CFTC and a member of the NFA or exempt from CFTC registration requirements for the reason indicated immediately below:

____ a) Trading Advisor has provided advice to 15 or fewer persons during the past 12 months and does not generally hold itself out to the public as a CTA.

____ b) Trading Advisor is a: (1) dealer, processor, broker, or seller in cash market transactions; or (2) nonprofit, voluntary membership, trade association, or farm organization, which provides advice on the sale of purchase of commodities and commodity futures contracts (including foreign futures contracts), options on commodities, options on commodity futures contracts, forward contracts, spot and forward currency contracts, precious metals, and any similar instrument (collectively, "*Commodity Interests*"), and any trading advice is solely incidental to the conduct of its business as such.

____ c) Trading Advisor is a relative of the Customer. Trading Advisor's relationship to the Customer is _____.

____ d) Trading Advisor is a foreign-based entity, located outside the United States, and Trading Advisor only solicits or exercises discretionary trading authority over the accounts of non-U.S. persons.
